#### TERMS AND CONDITIONS OF CILTSA ORGANISATIONAL MEMBERSHIP

- Organisational Membership of the Institute aims to fill a number of purposes:
- The encouragement of younger staff members to join in the activities of the Institute and through this to promote their professional development and networking ability.
- To improve their understanding of the interdependence of all areas of the supply chain and the necessity for the integration of processes to achieve a seamless continuum and the optimum outputs for the consumer.
- To encourage them to move towards the attainment of Chartered membership as a professional qualification in the field of Logistics and Transport.
- To strengthen the ties between the industry and the Institute so that activities of the Institute are better focused and the delivery of membership value is increased to the mutual benefit of all parties.
- To foster and improve knowledge and expertise and reward the application of professional principles to the management and execution of businesses in the Logistics and Transport field.
- To provide a forum in which all views can be exchanged and knowledge increased.
- Members joined to CILTSA through Organisational Membership are encouraged to participate in all activities of the Institute and are entitled to claim member discounts to Institute events. However Organisational members have non-voting status and individuals may not claim post-nominals or qualifications by right of their Organisational Membership.
- Organisational Members' representatives will receive communications and publications of the Institute automatically and may be Required to distribute information to the other members joined under their Organisational Membership Scheme.
- Organisational Members may display their Certificate of Membership in their place of business and include the Institute Logo and their Organisational Membership on items of company stationery, provided that it is done to the satisfaction of the Institute and provided they maintain the financial integrity of their membership.

#### Member Substitution

In the event that you wish to change the composition of your nominated Organisational members, please give advice of this to the Executive Director. Membership substitutions of individual members of an Organisational Membership scheme may be undertaken at any time, but it may take up to a month for a change to become fully effective.

#### Individual Membership

Persons may progress from their membership through an Organisational Membership scheme to individual membership at Member level (MILT), or further to Chartered membership (CMILT) (FCILT). These are professional qualifications granted under the authority of a Royal Charter and recognised around the world as identifying an experienced professional in Logistics and Transport. To gain them will require a blend of academic achievement (although exemptions can be granted) and practical experience in positions of demonstrable responsibility. The Executive Director can give you further information if you require it.
